

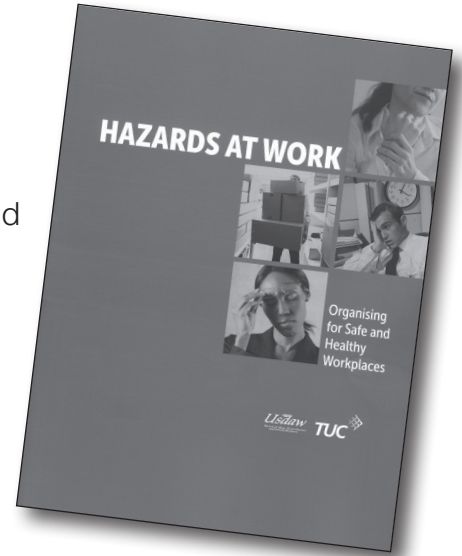

The book also contains HSE and other guidance, extensive checklists, case studies and web resources.
