#### Pensions Guide



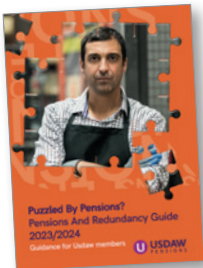

#### Auto-Enrolment Guide



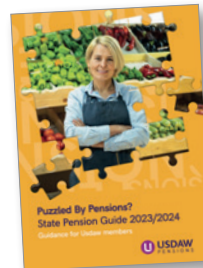
If you are eligible, your employer must now put you into a workplace pension and pay a contribution on your behalf. Find out if you qualify and what your rights are.
